

- In 1864, King Kamehameha V sold the island of Niihau to the Robinsons' ancestors, the Sinclair family, for \$10,000 worth of gold and, according to some accounts, a requirement that the family would promise to preserve the Native Hawaiian language and Niihau's unique way of life.
- **(VIOLATION #1: WHEN THE ANCESTORS OF THE PRESENT OWNERS PURCHASED NIIHAU IN 1864, THEY INTRODUCED SHEEP TO THE ISLAND)**TM
- "Niihau is yours," Kamehameha IV said when he signed the contract, according to the New York Times. "But the day may come when Hawaiians are not as strong in Hawaii as they are now. When that day comes, please do what you can to help them."
- The Niihau Cultural Heritage Foundation reports that Kamehameha IV agreed to sell the land, but died in 1863. Records show that his brother, Kamehameha V, completed the transaction on January 23, 1864.
- Niihau men aren't allowed to have long hair or wear earrings, and on Sundays, the entire village is expected to go to church.
- **(VIOLATION #2: WHY IS THE ENTIRE VILLAGE EXPECTED TO GO TO CHURCH IF SOME ARE NOT PRESBYTERIANS?)**TM

- **(VIOLATION #3: WHY ARE MEN NOT ALLOWED TO HAVE LONG HAIR OR WEAR EARRINGS?)™**
- In 1969, the Milwaukee Journal called Niihau a “Puritan paradise,” because of the religious culture impressed upon the Niihauans by the Robinsons — a family of “strict Scots Presbyterians,” according to the Journal — and the missionaries that came to Niihau decades before it was purchased.
- Alcohol and guns are not allowed on the island and, according to the New York Times, anyone caught breaking the rules can be evicted.
- **(VIOLATION #4: WHAT ABOUT WINE WITH COMMUNION? HOW WOULD THAT BE CONSIDERED BREAKING THE RULES SINCE JESUS CHRIST TURNED WATER INTO WINE?)™**
- Niihau Safaris has the exclusive hunting rights on the 72 square mile island owned since 1864 by one family. Only recently has hunting been permitted on this private Hawaiian island.
- **(VIOLATION #5: WHY ARE TOURIST ALLOWED TO HUNT WITH GUNS ON THE ISLAND AND THE NIIHAUANS ARE NOT ALLOWED TO HAVE THEIR OWN GUNS TO PROTECT THEMSELVES WHICH IS A VIOLATION OF THEIR 2ND AMENDMENT RIGHTS SINCE THERE WAS (1,2,3)™:**

- **(VIOLATION #6: THE OWNERS AND RESIDENTS HAVE HUNTED THE PIGS AND SHEEP FOR FOOD FOR MANY GENERATIONS USING MOSTLY ROPES AND KNIVES AND NOT BY THE GUNS OF TOURIST)TM**
- **(VIOLATION #7: THE OWNERS OF NIIHAU FORMED NIIHAU SAFARIS LTD. TO IMPLEMENT PROGRAMMED HARVESTING OF SHEEP AND PIGS TO PREVENT FURTHER DAMAGE TO NIIHAU ISLAND)TM**
- Elizabeth McHutchison Sinclair (1800–1892) purchased Niihau and parts of Kauai from Kamehameha V in 1864 for \$10,000 in gold. Sinclair chose Niihau over other options, including Waikiki and Pearl Harbor. By around 1875, Niihau's population consisted of about 350 Native Hawaiians, with 20,000 sheep.
- **(VIOLATION #8: The Niihau population has dropped below 50% as of the 2010 census)TM**

Makaloa (*Cyperus laevigatus*), a native sedge, used to grow on the edges of Niihau's three intermittent lakes. The stems were harvested and used to weave moena makaloa (mats), considered the "finest sleeping mats in Polynesia". The mats were valued by alii and foreign visitors alike, but by the end of the 19th century, Hawaiians had stopped weaving makaloa due to changes in population, culture, economics, and the environment.)TM**
- **(VIOLATION #10: WHY IS THERE NO OUTRIGGER CANOE RACING ASSOCIATION OR TEAM REPRESENTING NIIHAU WITH THE HCRA?)TM**
