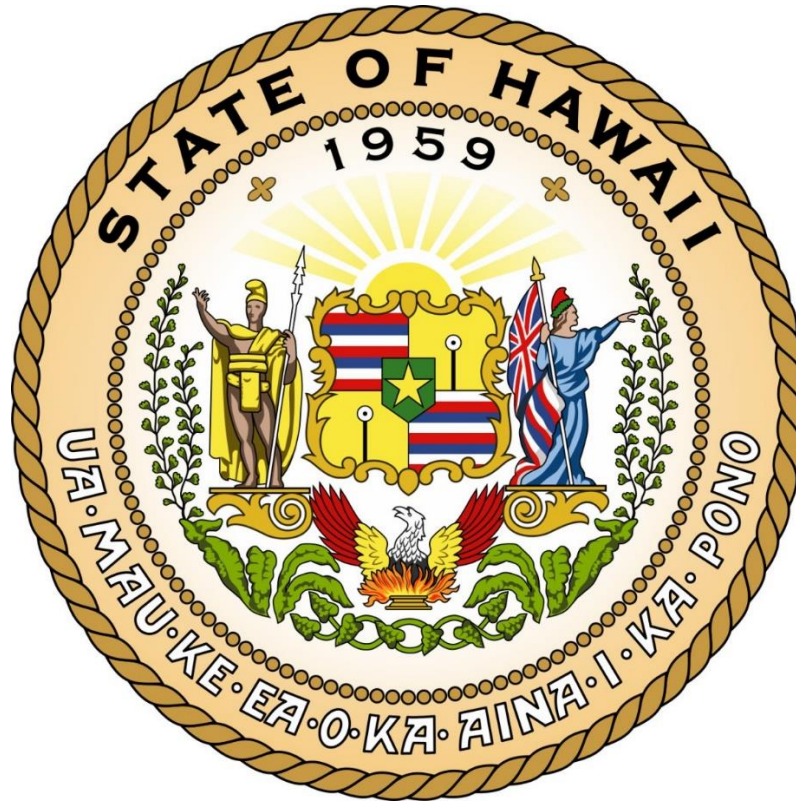

1. The **R**acketeer **I**nfluenced and **C**orrupt **O**rganizations Act, commonly referred to as the RICO Act or simply RICO, is a United States federal law that provides for extended criminal penalties and a civil cause of action for acts performed as part of an ongoing criminal organization
