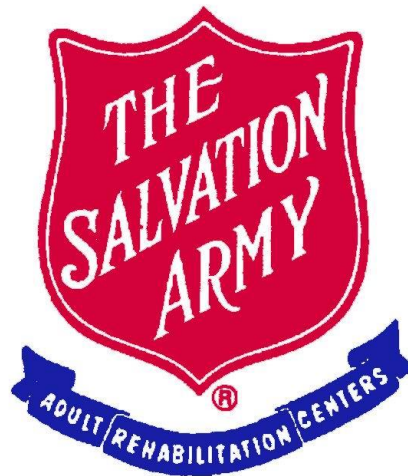

- HONOLULU, HAWAII ARC FINANCIAL DISABILITY FRAUD & DISABILITY BUS PASS FRAUD TOWARDS ITS BENEFICIARIES: SINCE THIS IS A WORK THERAPY PROGRAM, HOW CAN A BENEFICIARY BE PLACED ON FINANCIAL DISABILITY IN WHICH THE HONOLULU ARC KEEPS 2/3 OF THE FINANCIAL DISABILITY BENEFITS & EXPECTS THE DISABLED HONOLULU ARC BENEFICIARY TO WORK 40 HOURS A WEEK?
- IF THE HONOLULU ARC BENEFICIARY IS ABLE TO WORK 40 HOURS A WEEK, THEN WHY ARE THEY ALSO ALLOWED A DISABILITY BUS PASS?
- THE HONOLULU ARC INTAKE PAPERWORK DOES ASK YOU QUESTIONS ABOUT YOUR ABILITY TO WORK OR IF YOU HAVE ANY MEDICAL CONDITIONS THAT WOULD PREVENT YOU FROM WORKING.
- THE HONOLULU ARC WILL PLACE YOU ON DISABILITY AFTER YOU HAVE BEEN APPROVED FOR THEIR WORK THERAPY PROGRAM.

- **RAYMOND RENE VINOLE™** BENEFICIARY REQUESTED THAT HONOLULU ARC “CAPTAIN RON” PUT UP A SIGN/GRAPH FOR ALL OF THE BENEFICIARIES TO SEE REGARDING HOW ALL OF THE FUNDS ARE SPENT/DISPURSED TO KEEP EVERYONE MOTIVATED WHILE WORKING. “CAPTAIN RON” STATED THAT 88% GOES TO THE HONOLULU ARC PROGRAM & THE OTHER 12% ELSEWHERE & “CAPTAIN RON” SAID IT WAS A GOOD IDEA & SAID THAT HE WOULD PUT UP A SIGN/GRAPH IN

FRONT OF ALL OF THE BENEFICIARIES, BUT ACTUALLY NEVER DID PROVIDE THE SIGN/GRAPH. "CAPTAIN RON" ALSO STATED HE SAW SOMETHING SIMILAR AT ANOTHER ARC LOCATION.

- **HONOLULU ARC CHRISTIAN SHAMING BY "CAPTAIN ROBERTA" TOWARDS A BENEFICIARY, **RAYMOND RENE VINOLE™**, AFTER A MORNING DEVOTION BY BANNING, **RAYMOND RENE VINOLE™**, FROM FUTURE DEVOTIONS UNTIL PROPERLY TRAINED BY THE HONOLULU ARC "PASTOR TYSON". THIS WAS BECAUSE THE HAWAII STATE DIRECTOR FOR THE SALVATION ARMY WHO WAS A GUEST DID NOT UNDERSTAND BIBLICAL CHAPTER & VERSE REGARDING "THE CARRYING AWAY OF THE CHURCH" DURING A MORNING DEVOTION BY, **RAYMOND RENE VINOLE™**, & IN WHICH THE HAWAII STATE DIRECTOR FOR THE SALVATION ARMY ASKED "CAPTAIN ROBERTA" IN THE MIDDLE OF MY DEVOTION, "WHAT IS HE TALKING ABOUT?" & "CAPTAIN ROBERTA" RESPONDED BY SAYING "THE RAPTURE".**

- **HONOLULU ARC EXPIRED FOOD FOR THEIR BENEFICIARIES THAT CAUSES SICKNESS MOST LIKELY EXPIRED FOOD FROM THE LOCAL FOOD BANK, & MANY TIMES SAW EXPIRED FOOD ITEMS BEING SOLD IN THE ARC CANTINA TO THE BENEFICIARIES.**
- **HONOLULU ARC DISCRIMINATION TOWARDS NON-SMOKERS BY NOT LETTING NON-SMOKERS USE THE HONOLULU ARC IN-HOUSE GYM FOR THE FIRST 30 DAYS UPON THEIR ADMITTANCE INTO THE HONOLULU ARC PROGRAM.**

- HONOLULU ARC ALLOWING BENEFICIARY SMOKERS TO CONTINUE SMOKING UPON THEIR ADMITTANCE INTO THE HONOLULU ARC PROGRAM IN ORDER TO HAVE MORE BENEFICIARIES / MANPOWER WORKING TO KEEP PRODUCTION NUMBERS HIGHER, & IN WHICH ONE SPEAKER SPOKE ABOUT HOW BAD THE RELAPSE RATE % WAS FOR GRADUATES OF THE ARC PROGRAM.
- HONOLULU ARC PRO-ABORTION BY KICKING OUT A BENEFICIARY, **RAYMOND RENE VINOLE™**, FROM THEIR WORK THERAPY PROGRAM AFTER A WEDNESDAY EVENING SERVICE TESTIMONY SEGMENT “WHAT THE LORD HAS DONE FOR ME” IN WHICH THE BENEFICIARY, **RAYMOND RENE VINOLE™**, CLAIMED I WOULD GET ABORTION OVERTURNED IN THE STATE OF HAWAII.
- HONOLULU ARC LEADERSHIP SPREADING UNCIVILIZED STATEMENTS TO THE INTAKE COORDINATOR BEFORE ADMITTANCE OF BENEFICIARY, **RAYMOND RENE VINOLE™**, INTO THEIR WORK THERAPY PROGRAM.
- HONOLULU ARC “CAPTAIN RON” PRO-ANTICHRIST REGARDING SPRAY PAINTED UPSIDE-DOWN CROSS WITH A 666 FOR OVER A YEAR ON A TRASH BIN (WITNESS: R.K.N.) IN WHICH A BENEFICIARY, **RAYMOND RENE VINOLE™**, PLEADED WITH “CAPTAIN RON” FOR UP TO 3 WEEKS TO HAVE IT REMOVED IN FRONT OF ALL THE HONOLULU ARC BENEFICIARIES MULTIPLE TIMES DURING MORNING DEVOTIONS. “CAPTAIN RON” FINALLY HAD IT REMOVED ONLY AFTER HIGHER LEADERSHIP WERE ARRIVING FOR A TOUR OF THE HONOLULU ARC: WHICH CAPTAIN RON STATED IN FRONT OF ALL OF THE ARC BENEFICIARIES DURING A MORNING DEVOTION.
- PRIOR TO PLEADING WITH “CAPTIAN RON”, I PLEADED WITH A HONOLULU ARC WAREHOUSE MANAGEMENT EMPLOYEE, BUT HE WOULD NOT LET BENEFICIARY, **RAYMOND RENE VINOLE™**, REMOVE/WASH OFF THE SPRAY PAINTED 666 WITH AN UPSIDE CROSS BECAUSE HE STATED I WOULD BE DEFACING THE TRASH BIN WHICH HE STATED THE HONOLULU ARC DID NOT OWN.

- **I LATER FOUND OUT THAT THE HONOLULU ARC DOES OWN THE TRASH BIN THAT EVERYONE HAD TO WALK PAST IN ORDER TO GET INTO THE WAREHOUSE TO WORK.**

- **HAWAII SALVATION ARMY CHURCH MAJOR DISCLOSING JOAN KROC CENTER FUNDING @ 50% 50% WHILE I WAS AT THE JOAN KROC CENTER IN EVA BEACH, HAWAII TO PLAY VOLLEYBALL.**

THIS MAJOR & HIS WIFE LATER RELOCATED TO THE DOWNTOWN, SAN DIEGO SALVATION ARMY CHURCH.

- **HONOLULU ARC LEFT A FORMER BENEFICIARY, [RAYMOND RENE VINOLE™](#), SLEEPING ON THE SIDEWALK IN FRONT OF THEIR SALVATON ARMY STORE AFTER FORMER BENEFICIARY, [RAYMOND RENE VINOLE™](#), WANTED TO RE-ENTER THEIR WORK THERAPY PROGRAM AFTER LEAVING BECAUSE OF SPIRITUAL ABUSE BY “CAPTAIN ROBERTA” DURING 2016.**
- **HONOLULU ARC “CAPTAIN ROBERTA” KICKED GUEST, [RAYMOND RENE VINOLE™](#), OUT OF A 2017 WEDNESDAY NIGHT SERVICE UPON ENTERING WITH A HONOLULU ARC GRADUATE, JOHNNY DUCKWORTH, AS HIS GUEST BECAUSE “CAPTAIN ROBERTA” STATED IN FRONT OF JOHNNY DUCKWORTH & OTHER HONOLULU ARC BENEFICIARIES THAT, [RAYMOND RENE VINOLE™](#) HAD NOT COMPLETED HIS 6 MONTH PROGRAM.**
